To the City Council of Amesbury, Massachusetts

Respectfully represents the Massachusetts Electric Company d/b/a NATIONAL GRID of North Andover, Massachusetts, that it desires to construct a line of underground electric conduits, including the necessary sustaining and protecting fixtures, under and across the public way or ways hereinafter named.

Wherefore it prays that after due notice and hearing as provided by law, it be granted permission to excavate the public highways and to run and maintain underground electric conduits, together with such sustaining and protecting fixtures as it may find necessary for the transmission of electricity, said underground conduits to be located substantially in accordance with the plan filed herewith marked – Amesbury Landing - Amesbury, Massachusetts.

The following are the streets and highways referred to:

29491475 Amesbury Landing - National Grid to replace direct buried cable on Amesbury Landing. National Grid to install +/- 450 feet of 2-4inch conduit with 3PH UG primary from HDHH-1 to Pad-1. National Grid to install (1) Heavy Duty Handhole in right of way on Pleasant Valley Rd. National Grid to install 10 feet of 2-4inch conduit with 3PH UG primary from P101-38 to HDHH-1. National Grid to install 140 feet of 2-4inch conduit with 3PH UG primary from P101-37 to HDHH-1.
